## **Section F: Requested Remedy**

Ideally, all of these listed actions will be taken. They are listed in order of importance to me.

- All charges that Carroll College is pursuing against me will be dropped, as the core issue the college had was with the decidedly Catholic messages on the posters, and any charges added later would not have taken place without the original issues with the posters.
- Carroll College will modify its policies to explicitly protect Catholic students from retaliation or disciplinary action for spreading messages that are in line with the Catholic Church, as to be determined by a panel of practicing Catholics, with at least 51% of the panel consisting of ordained Catholic priests in good standing with the Church.
- Carroll College will issue a formal apology, signed by all Carroll faculty and staff I have been forced to deal with during the course of this debacle.
- Emily Weideman and other administrators will be sanctioned for their overreach and possibly let go. Any committees formed to determine culpability will consist of at least 51% ordained Catholic priests in good standing with the Church.
